She skated for the Anaheim Lady Ducks


Under19 team and afterwards spent the last five seasons competing as a member of the Minnesota State University Mavericks where she was a four-time WCHA All-Academic Team honoree.

It was the first day of geography class. The teacher was trying to get the class involved in a lively discussion. "What is the shape of the world?" she


asked. Immediately, James held up his hand and said, "My Dad says it's in terrible shape!" And most people would seem to agree with his dad.

"It was a gentleman I knew from the garden club. So, I asked him, 'Do you know anybody who has Queensland puppies'? He replied, 'I have three litters!'


"He told me where his place was, and I went over to see his puppies. These puppies are born white with a black undercoat. I told this gentle-

San Joaquin-Stanislaus CattleWomen



Stephen Dalkowski's greatest legacy may be the number of anecdotes (some more believable than others) surrounding his pitching ability.


He was said to have thrown a pitch that tore off part of a believed that this incident made Dalkowski even more nervous and contributed further to his wildness.



Steelhead at Nimbus Fish Hatchery on the American River in the Sacramento metropolitan area.

California's Central Valley rivers have seen what the California Department of Fish and Wildlife has described as "incredibly strong" steelhead returns this year.

This is in contrast to the record low fall-run Chinook salmon returns on the mainstem Sacramento River that have led to another year of severely limited salmon fishing opportunities or closures. A new record for the number of steelhead returning to the Mokelumne River was set this

A total of 1,749 steelhead, including 968 adults and 781 fish under 18 inches, have come back to the system this season, reported Wil-

liam Smith, manager of the Mokelumne River Fish Hatchery.

The previous record for total steelhead was in 2018 when the hatchery reported 530 adults and 638

juveniles, a total of 1168 fish. However, there was another year when the total number of adults was over 700 fish.

The majority of steelhead are in the 18" to 24"range, with a few larger fish mixed One of the steelhead returning this

year weighed 13-1/2 pounds, but it was apparently from Nimbus Fish Hatchery on the American River, said Smith.

A total of 210,000 yearling steelhead have been released into the system this year, according to Smith. The hatchery has taken close to 770,000 steelhead eggs this season.

Smith attributes the record steelhead run to the big water years in 2023 and 2024 to date, along with the CDFW and EBMUD's analysis of genetic studies and release strategies to improve the fish popu-

The record steelhead run follows a record salmon run. A total of 28,614 fall-run Chinook salmon returned to the Mokelumne River in 2023 — 5,700 of those fish were grilse (two-year-olds) and the rest were adults, said EBMUD Manager of Fisheries and



Wildlife Michelle Workman.

However, the Mokelumne River is a tributary of the San Joaquin River, not the Sacramento River, so it isn't included in the Sacramento River ocean abundance estimates developed by the Na-





tional Marine Fisheries Service that are the basis for determining ocean and river salmon fisheries in California every year.

The Mokelumne provided anglers with some solid steelhead fishing this year. Samuel Boyd Yoro of Watsonville and his nephew Bodhi had a great trip steelhead fishing on the Mokelumne below Camanche Dam in February.

"Bodhi caught and released his very first chrome-bright steelhead," said Yoro. "His Mokelumne River hatchery fish fought a solid bout, jumping and flipping out, but obviously not able to spit the hook out of its mouth.

Other Central Valley rivers saw robust steelhead runs also, according to CDFW data. The Feather River Fish Hatchery exceeded its 2023 total of some 1,200 steelhead on the very first day it opened its fish ladder in January, wrapping up the spawning season with 2,277 returning fish.

The Nimbus Fish Hatchery on the American River, home to both Central Valley steelhead and a larger coastal strain of Eel River steelhead introduced decades ago, saw 3,178 steelhead return to the hatchery in 2024. That is one of its highest totals in many years, according to CDFW

Meanwhile, the Pacific Fishery Management Council (PFMC) has produced three options for ocean salmon seasons beginning May 16, 2024, CDFW reported. Two of the three alternatives would authorize short ocean salmon season dates and establish small harvest limits for commercial and sport fishing off California in 2024. The third alternative would close the ocean fisheries off California for a second consecutive year. The alternatives were approved by the PFMC for pub-

lic review Monday. The 2024 stock abundance forecast for Sacramento River Fall Chinook, usually the most abundant stock in the ocean fishery, is only 213,600 adults. Abundance of Klamath River Fall Chinook is forecast at 180,700 adults.

Montana moose is on the loose

April 19 (UPI) — A wandering moose on the loose sparked a temporary shelter-in-place order at a Montana high school before the animal was chased off by a wildlife control officer and police.

Sean McCarthy, an urban



wildlife control officer for the city of Helena, said the female moose was spotted Friday morning outside Capital High School.

McCarthy initially used loud noises to chase the moose off school grounds, but the agitated animal repeatedly charged at him, leading him to request assistance from the Helena Police Department.

McCarthy told the Independent Record newspaper that the "stubborn and mangy old cow moose" had been seen on multiple occasions during the past week visiting the duck ponds at the nearby Lewis and Clark County Fairgrounds.

"We are blessed to live in an area where we get to experience wildlife," McCarthy said. "But, obviously this could pose a danger to the public."

A shelter-in-place order was instituted at the school while McCarthy and police officers chased the moose a safe distance north of campus.

Public drunken **Connecticut buzzards** hauled off to sober up overnight

April 19 (UPI) — An animal rescue group in Connecticut said a pair of drunk vultures were treated with fluids and "a big breakfast" before being released.

A Place Called Hope said that the "dynamic duo" had been "dumpster diving" and ended up eating something "that was fermented enough to cause severe intoxication."

The rescue said the vultures were initially thought to be seriously ill, but testing confirmed they were merely "too drunk to fly."

"They only needed fluids and to be tucked in overnight... and fed a BIG breakfast the next day," the post said.

The vultures were released back into the wild and successfully rejoined their colony. "Remember, your cocktail fruit that ends up in a dumpster can end up intoxicating wildlife if the dumpster is not kept closed," the post said.

Deysi Maldonado said she was visiting Galveston Island with her family and only realized hours after digging through the sand that her wedding ring set was missing from her finger.

Maldonado enlisted the help of the Galveston Island Treasure Hunters Club, a Facebook group for metal detecting enthusiasts.

Scott Pearse and Clyde Longworth took their metal detectors to the beach to search for the ring, but soon discovered Maldonado's diamond ring had already been

Caleb Brignac said he and his girlfriend had only been at the beach for about 15 minutes when they spotted a fishing net partially buried in the shallow water.

Brignac started digging the net out from the sand, and when he tossed a handful of shells to the side he saw a diamond ring fly through the air.

The couple saw Pearse and Longworth using his metal detectors nearby and approached them with their dis-

Pearse said it was a particularly lucky discovery, because it turned out the ring had been buried so deep in the sand likely wouldn't have found it.
