World's biggest aircraft carrier causes challenges

May 1 (UPI) — James Whomsley, a British YouTube engineering channel host, has built the world's biggest remote-controlled aircraft carrier model, according to Guinness World Records.

He also landed two re-



mote control model planes on the 16.46-foot model carrier, scoring another world's record.

The project took him three months. The model aircraft carrier is made from wood, foam and fiberglass. Expanding foam was used to make it waterproof.

Once the aircraft carrier model was built, Whomsley had to learn how top fly the remotecontrolled planes and then, after several failed attempts to land on the carrier he had to modify the planes.

"To have this idea, and then it actually work, that's amazing," Whomsley said. He added first-person view cameras to the model aircraft to be able to better see during the landings. The model planes he used were modified ready-tofly models.

The test flights and landings were done at Rudyard Lake in Straffordshire.

One of the model planes crashed into the water during testing.

The YouTube video shows his several attempts to land the planes as well as part of the building process.

Whomsley had already set a previous Guinness World Record with the fastest remote controlled jet-powered car. The car



Fear is a gift from God. It is

such a record? Because God will respond to our suffering!




It is the normal thing to do. Unfortunately, all too often we only pray when all else fails. It is as if God was not aware of our sickness or had no time to be concerned with our health.



Steelhead at Nimbus Fish Hatchery on the American River in the Sacramento metropolitan area.

California's Central Valley rivers have seen what the California Department of Fish and Wildlife has described as "incredibly strong" steelhead returns this year.

This is in contrast to the record low fall-run Chinook salmon returns on the mainstem Sacramento River that have led to another year of severely limited salmon fishing opportunities or closures. A new record for the number of steelhead returning to the Mokelumne River was set this year.

A total of 1,749 steelhead, including 968 adults and 781 fish under 18 inches, have come back to the system this season, reported William

Smith, manager of the Mokelumne River Fish Hatchery.

The previous record for total steelhead was in 2018 when the hatchery reported 530 adults and 638 juveniles, a total of 1168 fish. However, there was another year when the total number of adults was over 700 fish.

The majority of steelhead are

in the 18" to 24"range, with a few larger fish mixed One of the steelhead returning this year weighed 13-1/2 pounds, but it was apparently from Nimbus Fish Hatchery on the American River, said Smith. A total of 210,000 yearling steelhead have been released into the system this year, according to Smith. The hatchery has taken close to 770,000 steelhead eggs this season. Smith attributes the record steelhead run to the big water years in 2023 and 2024 to date, along with the CDFW and EBMUD's analysis of genetic studies and release strategies to improve the fish popu-

The record steelhead run follows a record salmon run. A total of 28,614 fall-run Chinook salmon returned to the Mokelumne River in 2023 — 5,700 of those fish were grilse (two-year-olds) and the rest were adults, said EBMUD Manager of Fisheries and Wildlife Michelle Workman.

lation.

However, the Mokelumne River is a tributary of the San Joaquin River, not the Sacramento River, so it isn't included in the Sacramento River ocean abundance estimates developed by the National Marine Fisheries Service that are the basis for determining ocean and river salmon fisheries in California every year.

The Mokelumne provided anglers with some solid steel-head fishing this year. Samuel Boyd Yoro of Watsonville and his nephew Bodhi had a great trip steelhead fishing on the Mokelumne below Camanche Dam in February.

"Bodhi caught and released his very first chrome-bright steelhead," said Yoro. "His Mokelumne River hatchery fish fought a solid bout, jumping and flipping out, but obviously not able to spit the hook out of its mouth.

Other Central Valley rivers saw robust steelhead runs also, according to CDFW data. The Feather River Fish Hatchery exceeded its 2023 total of some 1,200 steelhead on the very first day it opened its fish ladder in January, wrapping up the spawning season with 2,277 returning fish.

The Nimbus Fish Hatchery on the American River, home to both Central Valley steelhead and a larger coastal strain of Eel River steelhead introduced decades ago, saw 3,178 steelhead return to the



hatchery in 2024. That is one of its highest totals in many years, according to CDFW staff.

Meanwhile, the Pacific Fishery Management Council

(PFMC) has produced three options for ocean salmon seasons beginning May 16, 2024, CDFW reported. Two of the three alternatives would authorize short ocean salmon season dates and establish small harvest limits for commercial and sport fishing off California in 2024. The third alternative would close the ocean fisheries off California for a second consecutive year. The alternatives were approved by the PFMC for public review Monday.

The 2024 stock abundance forecast for Sacramento River Fall Chinook, usually the most abundant stock in the ocean fishery, is only 213,600 adults. Abundance of Klamath River Fall Chinook is forecast at 180,700 adults.

Spring wildflower displays as viewed from the visitor center are exceptional, with the face of the dam covered with lupine and the surrounding hills covered in hues of yellow, white, purple and blue. The habitat

around the visitor center attracts wildlife year around. Bald and golden eagles, osprey, red tail hawks and other raptors, waterfowl, a large variety of songbirds, deer, bobcat, coyote and many other native California foothill wildlife inhabitants are common visitors to the area around the facility.

Picnic tables and benches outside of the visitor center offer a chance to rest and enjoy the scenery

Perkins was arrested for an open count of murder and for being a prohibited person in possession of a firearm and ammunition.


Detectives determined Perkins had been staying at a residence in Stockton.

Detectives obtained a search warrant for the residence and located additional

evidence related to this investigation.

Perkins was booked into the Butte County Jail on the morning of April 27.

previously received a call from a resident who reported a victim had been shot in the 500 block of Lodgeview Drive, Oroville.

Deputies responded and located a male victim in the roadway.

Deputies and medical personnel immediately began providing the victim with medical

Despite the life-saving efforts provided, the victim did not survive.

Deputies and detectives conducted an investigation.

During the investigation, detectives located evidence that gave them cause to believe Joseph Perkins, age 54, of Oroville shot the victim.

Detectives located evidence that Perkins left the area in a vehicle after the shooting.

The vehicle Perkins left in was located unoccupied in the Kelly Ridge area later in the evening and was later found at the Stockton gas station.

State Prison. Davis was sentenced to serve ten years. In 1871, 29 prison inmates broke out in the largest prison escape in the West. The inmates included three of Verdi train robbers, but though Davis could easily have left with the others, he refused. Later, he cooperated with prison officials to provide information on the escapees. The prison warden, P.C. Hyman, later wrote to the Board of Pardons, explaining Davis's assistance and requesting his release. He was let go on February 16, 1875.

Though Davis had been a model prisoner, it didn't take him long to return to his old ways after his release. He was soon robbing stages again. He was cautious to rob only those stages that carried one shotgun messenger, but his cautiousness, in the end, would not be enough. On September 3, 1877, he went to rob a stagecoach at Warm Springs, Nevada. During the attempted robbery, he was shot and killed.

Treasure hunters have long searched in Six-Mile Canyon and along the Truckee River, looking for the gold that Davis was said to have buried, without success. Another legend abounds that the treasure is protected by the ghost of Jack Davis, who appears as a white screaming phantom to scare the hunters away.

Hero saves the day D'backs vs Dodgers

A pest control professional cleared a bee swarm of thousands while fans roared and later earned the nod for ceremonial first pitch before a delayed game Los Angeles Dodgers-Arizona Diamondbacks matchup in Phoenix.

The insect invasion occurred Tuesday at Chase Field. It caused a two-hour delay before the Diamondbacks beat the Dodgers 4-3.

Bees surrounded their queen in the cluster about 15 minutes before the game was set to begin. Umpires then met managers from both teams and Diamondbacks vice president of operations Mike Rock and opted to call in Matt Hilton to assess the situation.

They opted to call in Matt Hilton, branch manager at the local Blue Sky Pest Control office.

"It was a little nerve-racking, I'm not going to lie," Hilton told reporters. "A lot of pressure to get this game going. But I was happy to come and take care of it."

Hilton said that he left his son's tee ball game in Sunrise, Ariz., and drove about 30 miles to Chase Stadium. He put on a beekeeper outfit and used a scissor lift to ride under the bee swarm. The lift then elevated Hilton closer to danger before he used a nonpesticide spray on the swarm and vacuumed up the bees.

The crowd chanted "MVP" for the pest control ace as he was lowered back down to the field level. The Beatles' "Let it Bee" and Bonnie Tyler's "Holding Out for a Hero" played through the stadium speakers during the sequence.

Hilton then took to the mound, while still in his beekeeper outfit, and buzzed in his ceremonial first pitch.

"I didn't feel very prepared," Hilton said. "I'm not the best thrower in the world. ... It definitely wasn't a strike."

Hilton said there was a high probability that the pests were Africanized honey bees, also known as killer bees. He also said the bees might have turned aggressive if agitated by the net moving. Instead, they were taken out of the stadium and set free off-site.

First baseman Christian Walker went 3 for 5 with two home runs and three RBIs in the Diamondbacks 4-3 victory. He also ended the extra-innings affair with a walk-off, two-run homer. The Diamondbacks used seven pitchers to secure the win. That group allowed five hits and two earned runs and issued six walks over 10 innings.


While volcanic bombs are exciting, it's the bursts of gas spraying tiny crystals of metallic gold that surprise scientists, who estimate the volcano spews around 80 grams of gold a day — that's worth around \$6,000.

The gold has been found hundreds of miles away from Mount Erebus. Antarctic researchers have detected traces of the gold dust in ambient air up to 621 miles away from the volcano.
